The commonly recognised tupuna of Ngati Maru are: <b>Tume, Puata, Whakaruru, Tokotaua, Te Ikatere, Te Ikamatawhero, Te Ika Haehaekupenga, Pue, Patuwairua, Waingarunui, Tuihu</b>	Thank you for providing this information. At this stage we do not have a view on these ancestors. As discussed previously, OTS prefers that all Ngāti Maru (Taranaki) are covered by the definition, and that non-Ngāti Maru are not included unintentionally. Any further assistance or source material you can provide to help OTS understand Ngāti Maru ancestry would be appreciated (we thank you for supplying the Wai 1609 brief of evidence).

<p>2</p>	<p><b>Iwi/Hapu</b></p>	<p>What are the names of constituent iwi and hapu, both historical and contemporary?</p>	<p>The Iwi o Ngati Maru (Taranaki) Incorporated constitution lists 12 hapu as follows: Ngati Kui, Ngati Kehu, Ngati Teika, Ngati Te Arei, Ngati Rongonui, Ngati Hinemokai, Ngati Mihi, Ngati Kopua, Ngati Takahi, Ngati Rautao, Ngati Wharanui and Ngati Kura ki Uta. Several other hapu references possibly relating to Ngati Maru can also be found historical documents – these include Ngariki, Ngati Tamatapui and Tuhikitea.</p> <p>The above hapu are largely historical. While many Ngati Maru know the hapu groups from whom they descend, many do not.</p> <p>Currently the strength of Ngati Maru lies in the fact that each whanau has a widely recognised Ngati Maru tupuna name from whom they descend. This instantly identifies them as Ngati Maru, and these whanau are as large as, if not larger than our historical hapu. Many of these whanau are several hundred strong in their own right.</p> <p>For a more detailed description of the historical Ngati Maru hapu, see evidence of Karl Burrows and Holden Hohaia for the Ngati Maru claim to the Waitangi Tribunal (WAI 1609) attached as Appendix 1.</p>	<p>As discussed previously, OTS considers it to be the claimant group’s decision whether or not to list historical hapū in the claimant definition. Ultimately, OTS’s strong preference is for ancestry-based claimant definitions in which any lists of hapū (be they active/contemporary or historical) are illustrative but not exhaustive.</p> <p>As with the ancestor component of the claimant definition, OTS desires to understand how hapū listed in the claimant definition relate to the claimant group and would appreciate any further source material you are able to provide.</p> <p>OTS would also like to minimize overlapping claimant definitions between neighbouring groups. Could you please clarify if Ngati Kura ki Uta is distinct from the Ngāti Kura included in the Ngāti Mutunga Deed of Settlement?</p> <p>OTS would also like to clarify whether Ngati Teika is the same as Ngati Te Ika?</p>

While we also have close associations with neighbouring iwi marae such as Kohangamoia and Whakaahurangi, these are not recognised as Ngati Maru marae.	Some iwi include historical marae in their mandate strategy. Do you intend to include this level of detail?

Please note that the representation sought is for all claims, whether registered or un-registered.</p>	<p>WAI 136 (Tainui Tokotaua and others) for Ngati Maru WAI 583 (Pono Whakaruru and others) for Ngati Maru WAI 1609 (Karl Burrows and Holden Hohaia) for Ngati Maru</p>	<p>Wai claims are typically categorised as claims to be settled in full, or claims to be settled in part (so far as they relate to the settling group).</p> <p>Wai 136 and Wai 1609 have not been included in any previous settlements and so may be included in the Ngāti Maru claimant definition as claims to be settled in full.</p> <p>Wai 583 was included in the Ngāti Mutunga settlement as a claim to be settled in part, and so OTS considers that the parts of that claim that relate to Ngāti Mutunga (may be very small) are settled. The claim can still be included in the Ngāti Maru claimant definition as a claim to be settled in part, and the parts of that claim that relate to Ngāti Maru will be settled on the conclusion of a Ngāti Maru settlement.</p> <p>OTS previously identified other Taranaki region claims which may have aspects that relate to Ngāti Maru. We will review the statements of claim and provide further information in the near future. You may then wish to discuss the inclusion of these Wai claims with the Wai claimants (as claims to be settled in part).</p> <p>We suggest that you contact all Wai claimants whose claims are included to discuss the inclusion of their claim at an early stage. OTS may be able to provide contact details and advice on OTS policy if required.</p>

Clause d (i) of the trust deed outlines that the trust is established to: "...Act as the representative entity for the iwi of Ngati Maru..."</p> <p>Clause 2(b)(ii) of the trust deed also states that the object of the trust is to represent the interests of Ngati Maru:</p> <p>(ii) in negotiations with the Crown in relation to settlement of the Treaty of Waitangi claims of Ngati Maru (Taranaki).</p> <p>This description complies with Crown requirements.</p>

Once competing mandate claims are resolved, and it agreed that the Runanga be the entity that seeks mandate, the Runanga will be able move quickly to validate the register and progress elections. Once new trustees are elected, the Runanga could move immediately to seek mandate of the people to progress the claim.</p> <p>The Runanga should be in a position to hold new elections by 30 April</p>	<p>Our preference would be to also include cross-references to the First Schedule of Trust Deed relating to membership of Ngāti Maru (Taranaki) register  e.g. 1.1, 3.1, 4.1</p>
